1. I accept for use the equipment listed on this form and accept full responsibility for the care of this equipment.
2. I have made no misrepresentations to Great Bear Recreation Park, Inc. regarding this user's height, weight, age, or skier type, or snowboard stance.
3. I understand and am aware that skiing/snowboarding are hazardous activities and that the sport of skiing/snowboarding and the use of this equipment involve a risk of injury to any and all parts of this user's body. I hereby agree to freely and expressly assume and accept any and all risks of injury to the user of this equipment while skiing/snowboarding.
4. I understand that the ski equipment being used forms a part of or all of a ski/boot/binding system which will not release at all times or under all circumstances and that is not possible to predict every situation in which it will or will not release and that its use cannot guarantee this user's safety or freedom from injury while skiing.
5. I further agree and understand that this ski/boot/binding system may reduce, but does not eliminate the risk of injuries to the lower portion of this user's leg.
6. I understand that in snowboarding, the bindings will not release to prevent injury in any situation.
7. I agree: I alone will use the equipment: I will abide by all posted rules of safety: I will ski/snowboard under control in a manner consistent with my ability and without endangering others.
8. I agree: that I will release Great Bear Recreation Park, Inc., the City of Sioux Falls, its Parks and Recreation Board and/or its employees or agents from any and all responsibility or liability for injuries or damages to the user of the equipment listed on this form, or to any other person, resulting from negligence, installation, maintenance, the selection, adjustment, and use of this equipment, accepting myself the full responsibility for any and all such damage or injury which may result. I agree not to make a claim against or sue Great Bear Recreation Park, Inc., the City of Sioux Falls, its Parks and Recreation board and/or its employees or agents for injuries or damages relating to skiing and/or the use of the equipment.
9. I hereby agree to accept the terms and conditions of this contract. This document constitutes the final and entire agreement for this rental equipment between Great Bear Recreation Park, Inc. and the undersigned. There are no warranties, expressed or implied, which extend beyond the description of the ski equipment listed on this form and this equipment is accepted "as is."
10. I agree to return it in acceptable condition at the time agreed, to pay for all damage, and to pay the full retail value of all equipment not returned.
11. Upon receiving the rental equipment, I agree that I will:
  - Verify that the visual indicators on my bindings correspond to the settings marked down on this rental agreement.
  - Understand the instructions on the use and function of the rental equipment. If I do not understand the instructions, I will ask to be given instructions again until I do understand.
